Your membership fee includes 1 Short Sleeve Jersey, 1 Bib or Non-Bib Short, and 1 Pair of Socks. Please indicate the sizes.
- Page 4: Fill out this form if you wish to purchase additional clothing. Enter the sizes and quantities of additional items you wish to purchase.
- Page 5: Read the Rider Incentive Program (RIP). Initial and date the form.
- Page 6: Read the Accident Waiver and Release of Liability. Sign and date the form.

Additional Application Notes

- Annual TER racing membership begins and ends every calendar year on January 1 of every year. Your TER membership will expire on 12/31/2008.
- 2008 TER Membership includes clothing if sent by **12/31/2007**. After this date clothing is not guaranteed with your membership application and you may have to wait until our next clothing re-order.
- All racers must also be Team Evergreen Bicycle Club members; the club application is posted on www.teamevergreen.org website. (\$25.00 for individual or \$35.00 for family membership)
- In order to participate in the Team Evergreen Racing Rider Incentive Program (RIP), all team membership applications **MUST BE POST MARKED BY 12/31/2007**. After this date you will not be allowed to participate in any of the TER incentive programs, **NO EXCEPTIONS!** You may still become a team member and receive discounts from our sponsors but all rider incentive programs will be closed after the December 31st date.
- In order to encourage more women participation in the sport we will reimburse **New** TER women members 50% of their team membership fee after they compete and finish in a minimum of 3 races for that calendar year. In addition if they are entitled to receive RIP, and the RIP amount is greater than 50% of membership fee, then there will be **No** membership fee reimbursement. If they fail to finish 3 races then they will not receive any membership fee reimbursement.
- Category 1/2 and Pro MTB racers will qualify for additional support at the discretion of the racing committee.

Rider Incentive Program (RIP) Rules

Since our racing program is set up to distribute prizes and gift certificates to the riders at the end of the year, we must clarify these rules upfront so you know exactly what is expected of you if you wish to participate in our racing program. These rules also let you know of any deadlines that you may need to know of in order to get your results in to be counted for the end of the year awards party.

The total amount of the end of the year giveaway funds to the racers will be determined by the racing board committee and after all yearly team expenses, sponsor and travel expenses any other outstanding bills that the team may still owe have been paid. The board will then allocate "X" amount of funds and this amount will then be divided up amongst the riders. The riders who have participated in more races that season and those who place often on the podium will get more than those who simply race 1-2 races that season. The program is set up to reward those individuals who participate often in races.

Please review the **6 Rider Incentive Program** rules and initial below that you have read these rules and will abide by them if you are to participate in the program.

1. All riders who plan to participate in the Rider Incentive Program (RIP) must get their applications postmarked by **12/31/2007** in order to be in the RIP. Any rider applications received postmarked after this date will not be eligible for the RIP.
2. All riders must list **Team Evergreen Racing** as your primary sponsor on your race entry forms. If a rider chooses to list another sponsor then you will not receive TER Rider Incentive Program (RIP) points for that race.
3. All riders must wear at a minimum the Team Evergreen Racing jersey during your race. If the TER jersey is not worn then you will not get RIP credit for that race. Wearing of the full team kit is highly recommended. *The only exception to this rule will be for mtb races that last between 6-24 hours in length where multiple clothing changes might occur.*
4. You must enter all of your race results into our racing team's online database no later than 12/31/2008 in order to get credit for your 2008 racing results. If you enter your results after this date, then your results will not be counted in the program. This is to allow us to compile everyone's points and determine the payout to everyone before our end of the year awards party.
5. Every TER member is expected to contribute time in accomplishing the goals of the team and take leadership roles or, as a minimum, assist the team with **one (1)** of various TE or TER activities such as helping out with our road and / or mountain bike races, The Triple Bypass, lead training rides, etc.

Accident Waiver and Release of Liability

IN CONSIDERATION of being permitted to participate in any way in the Team Evergreen's Race Team and all other activities (collectively, "Activities") sponsored by Team Evergreen Bicycle Club, Inc. ("Club"),

I acknowledge that these Activities are an extreme test of a person's physical and mental limits, and I voluntarily assume all risks of all loss, damage or injury occurring in connection with such Activities. I fully understand that my participation carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, conditions of athletes, equipment, vehicular traffic, lack of hydration, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event. These risks affect not only athletes, but also volunteers. I hereby assume all of the risks of participating and/or volunteering in these Activities. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, or from dangerous or defective equipment or property owned, maintained or controlled by them.

I certify that I am physically fit, have sufficiently trained for participation in these Activities and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability form ("Waiver and Release") will be used by the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said Activities.

In consideration of my application and permitting me to participate in these Activities, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) WAIVE, RELEASE and DISCHARGE from any and all liability, claims, demands, actions or rights of action, which are related to my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me which are related to or are in any way connected with participation in all Club Activities (including, without limitation, all Race Team activities) or result from my traveling to or from these Activities, THE FOLLOWING ENTITIES OR PERSONS: Team Evergreen Bicycle Club, Inc. and its directors, officers, employees, volunteers, representatives, agents, contractors, the event holders, event sponsors, event directors, event volunteers and their successors, assigns and insurers; and (B) INDEMNIFY AND HOLD HARMLESS the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during these Activities. I UNDERSTAND THAT THIS IS A LEGAL DOCUMENT AND THAT BY SIGNING IT I AM GIVING UP MY RIGHT TO SUE OR OTHERWISE MAKE A CLAIM against the Club and other entities and persons mentioned in this paragraph.

I intend this Waiver and Release to be effective whether or not any loss, damage, injury or death RESULTS FROM NEGLIGENCE of the Club or any of its directors, officers, employees, volunteers, representatives, agents, contractors, the event holders, event sponsors, event directors, event volunteers and their successors, assigns and insurers. I understand that negligence means a failure to do an act which a reasonably careful person would do, or the doing of an act which a reasonably careful person would not do, under the same or similar circumstances to protect himself, herself or others from injury or death.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during this event. In the event of accident and/or injury I further consent to the release of any and all transport, treatment and or medical information to the Club relating there to.

I understand that at these Activities or related events, I may be photographed. I agree to allow my photo, video, film likeness and email address to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and or assigns.

I agree to wear an ANSI or SNELL approved helmet and to ride in accordance with all applicable laws.

This Waiver and Release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
